NINETY-DAY LIMITED WARRANTY

WARRANTY:

This Applied Concepts, Inc. (ACI) product warranty extends to the original purchaser of this product.

WARRANTY DURATION:

This ACI product is warranted to the original purchaser for a period of 90 days from the original purchase date.

WARRANTY COVERAGE:
